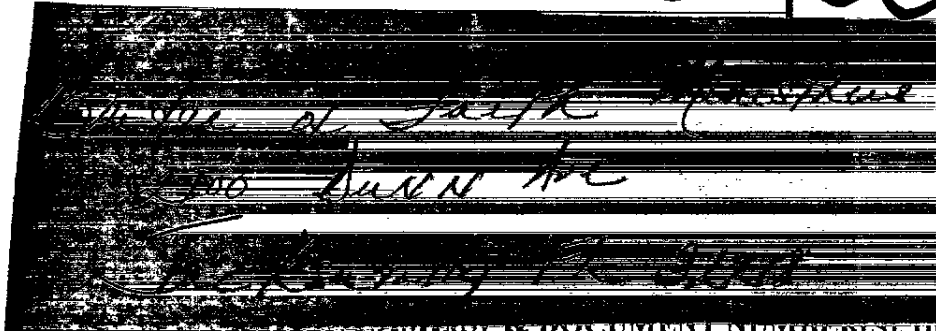

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617.0202, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I Name

ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

The purpose of which the organization called The Bridge Of Faith, INC. is organized are exclusively religious, charitable, literary and educational within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law. The missionary organization is designed to eliminate ignorance, fear, and indifference through direct support and involvement with pastors in Africa and pastors in the United States. It is also organized to develop a relationship basis of support and interaction on a consistent and long-term basis.

ARTICLE V
Limitation of Corporate powers

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE VI
Dissolution

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction, of the county in which the principal office of the organization is then located, exclusively for such purposes.

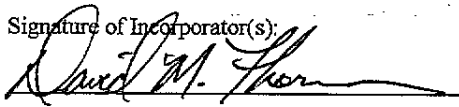

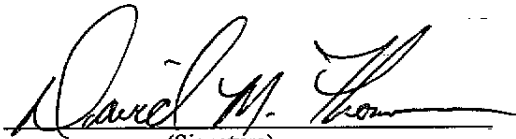

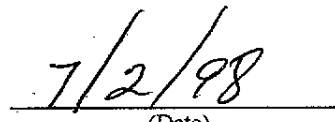
