ARTICLES OF INCORPORATION

The undersigned incorporator, being a natural person, competent to contract, subscribes to these Articles of Incorporation to form a non-stock corporation, not organized for profit, under the provisions and subject to the requirements of law for such cases made and provided by the State of Florida.

ARTICLE I

Name. The name of this corporation shall be:

JOHN 3:16 MINISTRIES, INC.

ARTICLE II

<u>Principle Place of Business</u>. The principle place of business of the corporation shall be in the State of Florida, County of Volusia and may be changed from time to time as determined by the Board of Directors. The initial mailing address of the corporation shall be:

1475 Steeplechase Lane Deltona, Florida 32725

ARTICLE III

<u>Business and Activities</u>. This corporation is organized for religious and benevolent purposes and no part of the net earnings shall inure to the benefit of any individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth herein. Specifically its purposes are as follows:

To disseminate Christian information and to engage in activities for the promotion of the Christian ethic and Christian living and to promote Christian ministries through Christian activities consistent therewith, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (3) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Upon dissolution or final liquidation of the corporation, all assets of the corporation shall be applied and distributed as follows:

- (a) All liabilities and obligations of the corporation shall be paid, satisfied and discharged or adequate provision shall be made therefore.
- (b) Assets held by the corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements.
- (c) other assets, if any, shall be transferred or conveyed to one or more domestic or foreign corporations, societies or organizations engaged in activities substantially similar to those of this corporation, provided, that any such distributee, shall at the time of such distribution, hold a tax exempt status under the laws and regulations of the Internal Revenue Service of the United States of America.

ARTICLE IV

This organization shall have no members and all of its affairs shall be regulated and directed by a Board of Directors consisting of three (3) members, which board of directors shall be a self-perpetuating body and the number thereof may be increased or decreased by change in the by-laws of the corporation, provided, however, that the number there of shall not at any time be less than three (3).

<u>Term of Existence</u>. This corporation shall have perpetual existence.

ARTICLE V

<u>Initial Registered Office and Agent</u>. The street address of the initial registered office of the corporation is 1475 Steeplechase Lane, Deltona, Florida 32725, and the name of the initial registered agent of the corporation at that address is Rafael Toledo, Jr.
