ARTICLES OF INCORPORATION PUBLISHED OF CORPORATION

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is Orphan Animal Rescue, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 3751 N.E. 170 Street, #2, North Miami Beach, FL 33160.

ARTICLE III: PURPOSE

The specific nature of business is to rescue any and all types of animals, including but not limited to dogs, cats, birds, etc. for the specific purpose of feeding them, attending to all their medical needs of whatever nature or kind, administering any and all shots, de-worming, licensing, spading, dental, and caring for them in any manner possible to insure that all animals are fed and brought to a healthy status and then placed into a home that is screened to insure that each and every animal receives the love and care deserved and needed.

ARTICLE IV: QUALIFICATION
