A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

CITIZENS AGAINST LEGISLATIVE ABUSE, INC.

The address of the principal office of this corporation shall be 316 South Baylen Street, Suite 600, Pensacola, Florida 32501 and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to act as a legislative watchdog.

ARTICLE III.

The number of Officers shall be two. The names and address' of the persons serving as officers is as follows.


