ARTICLE OF INCORPORATION

ARTICLE I

The corporation is a non-profit corporation.

ARTICLE II

The name of the corporation is Original Miracle Prayer Temple, Inc. The mailing address is: P. O. Box 251 Fort Pierce, Florida 34954. The president of the said corporation and address are: Estelle Stevens, 1600 Avenue S, Fort Pierce, Florida 34950. The phone number is (561) 461-0491 or 489-8136.

ARTICLE III

The specific purposes for which the corporation is organized is to maintain a place or places of worship; teach, preach and pursue a religious association and house of prayer; provide a place or places for young people to assemble where they can feel loved and wanted; provide an atmosphere of learning and education to instill a sense of self-pride and accomplishment in our community's youth; instruct and encourage members to be drugfree and seek direction from the Lord Jesus Christ; rent, buy, sell and lease property for the said purposes.

ARTICLE IV

The affairs of the corporation shall be conducted by a Board of Trustees, not less than three persons, not more than five. Persons shall be elected by members of the corporation at annual business meetings. The elected Trustees shall serve one year or until a successor is disqualified. If they serve in all honesty, they can serve two years.

The Trustees shall elect officers for the corporation to perform such duties as stated in the Church guide or by-laws. Trustees shall present the names at the annual business meeting to be voted and approved by the corporation. For any vote to pass, it must be by majority, three or four of the members must be present at any meeting.

No by-laws, amendments shall be acted upon by the corporation until given due notice of such profound amendment in a regular Trustee meeting one month prior to an annual business meeting.
