The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: **BREAD OF LIFE MINISTRIES OF AMERICA, INC.**, (hereinafter referred to as the "Ministry").

ARTICLE II. PURPOSE

The purpose and object of the Ministry shall be to teach and spread the gospel of Jesus Christ, to utilize biblically based methodology in research, counseling and professional approaches to healing and ministering to the body, mind, and spirit. The Ministry shall also conduct any and all business consistent with the laws of the State of Florida and United States of America.

ARTICLE III. PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be 8601 Brixton Court, Jacksonville, Florida 32244. The mail address shall be P.O. Box 12661, Jacksonville, Florida 32209.

ARTICLE VII. NON-PROFIT STATUS

No part of the income of this corporation shall be distributed to the Members. Upon dissolution or final liquidation as permitted by the court having jurisdiction thereof, all remaining assets shall be distributed to an organization under 501(c) of the Internal Revenue Service Code.

ARTICLE VII. BY-LAWS

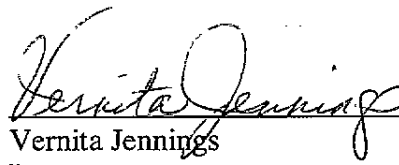
The Board of Directors shall adopt by a majority vote the original By-Laws of the ministry.

ARTICLE V. MEMBERSHIP

ARTICLE VI. BOARD OF DIRECTORS

The business affairs of the Ministry shall be managed by the Board of Directors. 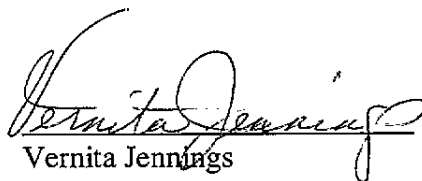
**CERTIFICATE OF DESIGNATION OF
