OF

We, the undersigned residents of the State of Florida, being eighteen (18) or more years of age, do hereby associate ourselves together for the purpose of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation is: **CHAPEL FOUNDATION OF IRCC, INC.**

ARTICLE II

Principal Office

The mailing and street address of the principal office of the corporation is 6205 Murrell Road, Melbourne, Florida 32940. The name of the initial registered agent of the corporation at that address is James E. Ferguson.

ARTICLE III

Statement of Corporate Nature

This is a corporation not for profit organized for charitable and religious purposes, including, but not limited to, the conduct of religious services and other religious and charitable purposes, pursuant to the Florida Not For Profit Corporation Act set forth in Chapter 617, *Florida Statutes*.

ARTICLE IV

Duration

The period of duration of this corporation not for profit shall be perpetual.

ARTICLE V

General and Specific Purposes

The specific and primary purposes for which this corporation is to conduct religious services and to be involved with other religious and charitable activities.

ARTICLE VI

Member corporation

This corporation shall be a non-member corporation.

ARTICLE VII

Non Stock Corporation

This corporation shall be non stock and no dividends or pecuniary profits shall be declared or paid to anyone.

ARTICLE XI

Amendment to Articles

ARTICLE XII

Dissolution

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of

the organization is then located, exclusively for such purposes.




