ARTICLES OF INCORPORATION  
OF  
CENTRAL FLORIDA EMPLOYMENT SERVICES, INCORPORATED

Article I

The name of the Corporation is CENTRAL FLORIDA EMPLOYMENT SERVICES, INCORPORATED.

Article II

Its registered office in the State of Florida is 2704 Rew Circle, Suite 105B, in the City of Ocoee, County of Orange. The name of its registered agent at such address is Yaphet Oliphant.

Article III

The specific purposes for which this *non-profit* corporation is being organized are:

- a) to engage in employment counseling, skill training
- b) conduct educational employment workshops


payments and distribution in futherance of the purpose set forth in Article 3.


