ARTICLES OF INCORPORATION
FOR
Children For Jesus, Inc.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: Children For Jesus, Inc.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

Business: 10521 Mahogany Key Cir #204, Miami, FL 33196

Mailing: PO Box 924708, Miami, FL 33092-4708

ARTICLE III PURPOSE

The specific purposes for which the corporation is organized are:

Section 1. The purpose of this organization shall be to help needy children.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

Section 1. The chapter shall be managed by a Board of Directors. Each Director shall be at least 18 years of age.

Section 2. The officers of the Board of Directors shall be the chapter President, Vice President, Secretary, and Treasurer, or Secretary/Treasurer, and a maximum of five additional directors, or six, if the offices of Secretary and Treasurer are combined.

Section 3. Officers and Board members shall be elected for a two year term. Elections shall be held every other year beginning July 1998.

Section 4. Any member in good standing is eligible to serve as an officer of this organization.

Section 5. A nominating committee of three persons chosen from the Board of Directors shall select one nominee for each office.

- a. Additional nominations may be made from the floor.
- b. Consent of nominee must be obtained prior to nomination.
- c. If there is only one nominee for each office, election may be by voice.
- d. Board members shall be elected by a majority vote of the Board.

Section 6. A member in good standing, for purposes of consideration of Board Membership, shall be a Judeo-Christian, regularly attending a church, who has been active or supportive of Children For Jesus, Inc. prior to election to office. This person shall adhere to Children For Jesus, Inc. By Laws. In cases of Board members non compliance, they may be put on probation for 3 months by a majority vote of the board to determine if there is adequate cause for dismissal from the board. A majority vote is required for dismissal.

Section 7. Vacancies occurring in office shall be filled by the majority vote of the Board for the remaining term.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.

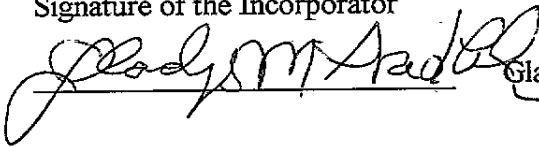

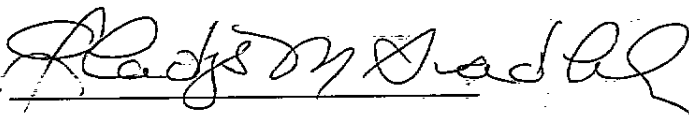
