- ONE:** The name and address of this principal corporation is United Believers Community Development, Inc., 601 Kilgore Street, Wildwood, FL 34785. The Corporation is organized PURSUANT TO the FLORIDA Non-profit Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. To establish structured support services for homeless and economically disadvantaged individuals, families and juvenile to a life of self-sufficiency. The programs will consist of, but shall not be limited to: Chilcare, Outreach Advocacy Programs For The Youth At High Risk, Health Care, Homeless, Housing for the Aged, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement, and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS, and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR:** The address of the registered office is United Believers Community Development, Inc. 601 Kilgore Street, Wildwood, FL 34785.
- FIVE:**
- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.


