
**ARTICLES OF INCORPORATION

ONE: The name and address of this principal corporation is United Believers in Christ, Inc. 601 Kilgore Street, Wildwood, FL 34785. The Corporation is organized PURSUANT TO the FLORIDA Non-profit Code.

TWO: This corporation is a nonprofit Religious Benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purpose and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.




