ARTICLES OF INCORPORATION

OF

KINGDOM BUILDERS OUTREACH MINISTRY, INC.

We the undersigned natural persons of the age of eighteen years or more, all of whom are citizens of the State of Florida, acting as incorporators of a corporation under Chapter 617, of the Florida Statutes, the Florida Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE 1.

The name of the Corporation is:

ARTICLE IL

ARTICLE III.

The purpose or purposes for which the corporation is organized are:

- 1. To sponsor and encourage the teaching and preaching of the Gospel of Jesus Christ and of God's Holy Word, including assistance to other Christian ministers and ministries.
- 2. To produce and distribute video and audio tapes and printed literature of all kinds for the purpose of Christian teaching, preaching, and witnessing.
- 3. To develop, train and sponsor Christian witnesses at home and abroad.
