ARTICLES OF INCORPORATION

ARTICLE I - NAME AND ADDRESS

ARTICLE II - DURATION

The duration of the Corporation is perpetual.

ARTICLE III- PURPOSES

A. This corporation is a not-for-profit corporation organized under chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- 1.) The corporation is established to fund various charities through providing volunteer workers at different events which our corporation is contracted with.
- 2.) To establish and maintain a liaison with various charities and providing a network of companies and charities that will work together to establish methods of generating funds with volunteer workers so that are corporation can in turn supplement various community charities
- 3.) To communicate with the public, the opportunities which are available by providing charity volunteers from their organization, to work with the Tropicana Dome, and the City of ST Petersburg, to generate funding which will be divided among participating groups.
- 4.) To stimulate the production, exchange and dissemination of ideals and information among local charities.
- 5.) To advise and provide consultants and consultant services regarding charitable programs.

The Corporation is organized and is to be operated exclusively for charitable and educational purposes within the meaning of section 501 (c) 3 and 170 (c) (2) (b) of the Internal Revenue Code or corresponding provisions of any future United States Internal Revenue Law.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provide, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall insure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its statement purposes.

#### ARTICLE IV - MEMBERS

A. Members. The corporation shall have Voting members, who shall be elected ( and may be removed) by the Voting members, and who shall have all the rights and privileges of members of the corporation. The Bylaws may provide for Non-voting members of one or more classes, who shall be admitted in such manner and who shall not have the right to vote. The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three (3).

#### ARTICLE VII - OFFICERS

The officers of the Corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors ( and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.
