The undersigned, acting as incorporator(s) of a corporation pursuant of chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I Name

The qualifications, the time and manner of electing or appointing, the duties of, the terms of office, and the manner removing offices shall be as set forth in *Florida Statutes*, Chapter 617.
