The undersigned, acting as incorporator(s) of a corporation pursuant of chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### **ARTICLE I Name**

The name of the corporation shall be: Jupiter Academy Middle School, Inc.

### **ARTICLE II Principal Office**

The principal place of business and mailing address of this corporation shall be: 125 South Pennock Lane  
Jupiter, Florida 33458

### **ARTICLE III Purpose(s)**

The specific purpose for which this corporation is organized is to provide an education for post-elementary school students through a nonprofit endeavor.

### **ARTICLE IV Manner Of Election of Directors**

The Directors of the corporation are appointed from community members and interested parties within the educational community.

### **ARTICLE V Limitation of Corporate Powers**

1. Board of Directors. The power of this Corporation shall be exercised, its properties controlled and affairs conducted by a board of at least 3 Directors, but not exceeding 11 Directors. The numbers of Directors provided for these Articles of Incorporation may be changed by a bylaw adopted by the Board of Directors.
2. Election of Directors. The method of electing Directors shall be as set forth in *Florida Statutes*, Chapter 617.
3. Elective Officers. The officers of this Corporation shall be a President, Vice President, Secretary, and Treasurer. Other offices and officers may be established or appointed by the members of this Corporation at any regular annual meeting or any special meeting of members called for such purpose. The qualifications, the time and manner of electing or appointing, the duties of, the terms of office, and the manner removing offices shall be as set forth in *Florida Statutes*, Chapter 617.
