Pursuant to the provisions of Section 617.1006 of the Florida Not For Profit Corporation Act, JUBILEE/CENTENNIAL, INC., a Florida not-for-profit corporation (the "Corporation"), adopts the following amendments to its Amended and Restated Articles of Incorporation.


1. The name of the Corporation is JUBILEE/CENTENNIAL, INC.
2. Article I of the Corporation's Amended and Restated Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

ARTICLE I

The name of the Corporation is Jubilee/Pueblo del Sol, Inc.

3. The foregoing Second Amendment to the Amended and Restated Articles of Incorporation were duly adopted and approved by the sole member and all of the directors of the Corporation by written consent in lieu of a meeting on February 21, 2000. The number of votes cast was sufficient for approval.
