# AMENDMENT TO ARTICLES OF INCORPORATION OF SOUTH DUNNELLON CIVIC ASSOCIATION, INC.

Effective upon filing with the Florida Department of State, there being no members entitled to vote on this amendment and, therefore, pursuant to a resolution duly adopted by its Board of Directors on May 14, 2007, South Dunnellon Civic Association, Inc., a Florida not-for-profit corporation, hereby adopts the following amendments to its Articles of Incorporation filed with the Department of State of Florida on July 24, 1998.

## Article II – Principal Office

The principal place of business and mailing address of this corporation shall be:

1962 West Test Court Street Dunnellon, FL 34431

### Article III - Purpose

The purpose of this corporation shall be exclusively charitable in nature, to wit: to engage exclusively in activities for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the correspondence provisions of any future federal tax code), and within these restrictions to engage in activities including but not limited to:

- (a) to operate exclusively for charitable purposes to create a stronger bond between the low income and minority residents of South Dunnellon so as to empower them to improve the conditions of their community;
- (b) to promote a stronger interest among the members in the civic affairs affecting their community in Citrus County.

#### Article VII - Duration

The duration of this not-for-profit corporation is perpetual.

#### Article VIII - Dissolution

(k) Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future federal tax code) as the Board of Directors shall determine.
