ARTICLES OF INCORPORATION

OF

CLEVELAND AVENUE BUSINESS ASSOCIATION, INC.



The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be CLEVELAND AVENUE BUSINESS ASSOCIATION, INC.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: City of Fort Myers Planning Department, P.O. Drawer 2217, 2200 Second Street, Fort Myers, Florida 33902-2217.

ARTICLE III

PURPOSE(S)

The specific purposes for which this corporation is organized are:

- 1. To retain existing businesses and to encourage the expansion of those businesses in the Cleveland Avenue corridor.
- 2. To attract favorable new businesses to the Cleveland Avenue corridor.
- 3. To enhance the aesthetic appearance of Cleveland Avenue throughout the corporate limits of the City of Fort Myers, Florida.
- 4. To function in an advisory/liaison capacity to the City of Fort Myers and all other public, semi-public, and private agencies who impact the Cleveland Avenue business community. This organization shall, however, be totally independent

- from the City of Fort Myers, and any advising or reporting to the City of Fort Myers shall be at the discretion of the Association.
- To assist in the implementation of the Cleveland Avenue Improvement Program, 5. which is the adopted community redevelopment plan for Cleveland Avenue, pursuant to Chapter 163, F.S. The assistance provided, however, shall be on an independent basis as noted in Paragraph 4 above, and this organization shall not be construed to be an advisory committee or board of the City of Fort Myers.
- To operate exclusively for such specific purposes as will qualify it as an exempt 6. organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS
