We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

MIAMI DADE RECOVERY FOUNDATION INC.

The address of the principal office of this corporation shall be 655 Northeast 149th Street, Miami, Florida 33161, and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is community and residence rehabilitation and education.
