ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The text of the Amendment adopted is as follows:

A. The first sentence of Article I of the Articles of Incorporation is hereby amended to read as follows:

The name of the corporation is Saddlebrook at Davie Homeowners Association, Inc., a Florida corporation not-for-profit (hereinafter referred to as the "Association").
