**ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation shall be **MILLENNIUM ASSOCIATION OF CHURCHES, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 3144 Third Avenue South, St Petersburg, FL 33712.

ARTICLE III - PURPOSE

The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

Our mission is to discern the movement of God through the activity of the Holy Spirit as we prepare to enter the new millennium, to the end, that the body of Christ might be edified, equipped and energized to do effective and relevant ministry in the meeting of people's spiritual needs.

We will fulfill our mission by providing an annual conference which will provide seminars, workshops, panel discussions and other learning settings for pastors. Continuing Education Units can be earned by participating pastors. We will circulate a newsletter quarterly for sharing information about upcoming events and other pertinent matters.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS
