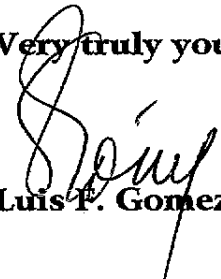

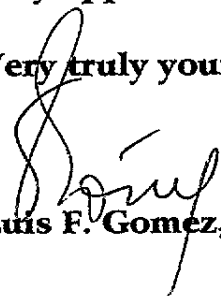

ARTICLES OF INCORPORATION

OF

IGLESIA PENTECOSTAL NUEVA ESPERANZA, INC.

(Pentecostal Church of New Hope, Inc.)

We the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617 of the Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be:

Iglesia Pentecostal Nueva Esperanza, Inc.

ARTICLE II

EXISTENCE OF AND GENERAL NATURE OF BUSINESS

The existence of the corporation shall be perpetual. It shall commence upon the filing of these Articles with the Secretary Of State of the State of Florida.

The general nature of the business to be conducted by the corporation shall be providing spiritual and religious assistance to its members and the general public.

ARTICLE III

POWERS

The corporation shall have all the statutory powers of a corporation not for profit and all of the powers and duties set forth in Chapter 617 of the Laws of the State of Florida, except where

variances permitted by law appear in these Articles.

The corporation may enter into lease agreements and may acquire and enter into agreements acquiring real estate, lease-holds, memberships and other possessory or use interests for terms up to and including 99 years.

ARTICLE IV

MEMBERS

All persons (legal or human) whose profession, occupation, education, training or special interest is related to the christian faith shall be eligible for membership in the corporation. The qualification of members and the manner of their admissions is to be provided for in the by-laws of the corporation.

ARTICLE V

INITIAL BOARD OF DIRECTORS

The initial Board of Directors of the Corporation shall be the persons whose names and addresses follow:

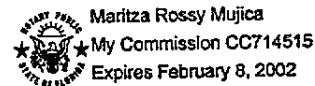
