THE UNDERSIGNED, for purposes of forming a not-for profit corporation pursuant to Chapter 617, Florida Statutes, does hereby submit as its Articles of Incorporation:

ARTICLE I

NAME OF CORPORATION

The name of this Corporation shall be:

WILDCAT BAND BOOSTERS, INC.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation shall be to promote the interests and activities of the Royal Palm Beach High School Wildcat Band, and to engage in any and all lawful business permitted under the laws of the United States of America, and the State of Florida.

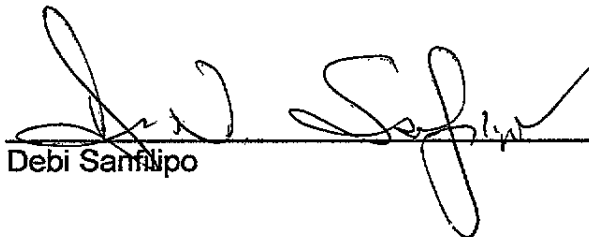
