**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF
WHITELOCK FARMS HOMEOWNERS ASSOCIATION, INC.**

These Articles of Amendment to Articles of Incorporation of Whitelock Farms Homeowners Association, Inc., are made effective December 1, 1999, by **WHITELOCK FARMS HOMEOWNERS ASSOCIATION, INC.** (the "Association").

RECITALS:

A. The Association desires to amend its Articles of Incorporation as more particularly described hereafter and these Articles of Amendment have been proposed and approved by the Association's Board of Directors on December 1, 1999 and have been adopted by the affirmative vote of more than a majority of the votes of the Members on December 1st, 1999, which vote is sufficient for approval.

NOW THEREFORE, the Association hereby amends its Articles of Incorporation as follows:

1. All defined terms contained in these Articles of Amendment, shall have the same meanings as such terms are defined by the Articles of Incorporation.

2. Article III, paragraph B of the Articles of Incorporation is hereby modified in its entirety as follows:

B. To own, maintain, repair and replace the Common Area, including without limitation the streets, street lights, landscaping, structures, and other improvements located thereon, and the retention or detention ponds, swales, storm drains and other facilities constituting the Surface Water or Storm Water Management System pursuant to St. Johns River Water Management District Permit No. 4-109-0210-ERP (as the same may be modified from time to time) for which the obligation to maintain and repair has been delegated to and accepted by the Association.

3. Except as specifically amended hereby, the Articles of Incorporation shall remain in full force and effect.

IN WITNESS WHEREOF, the Association has executed these Articles of Amendment to Articles of Incorporation effective the date first above written.

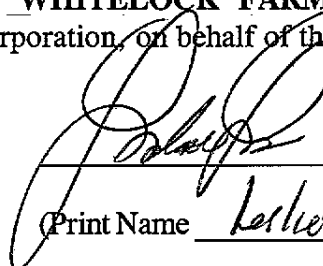

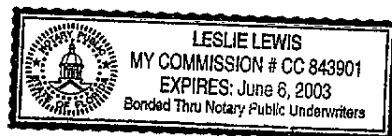

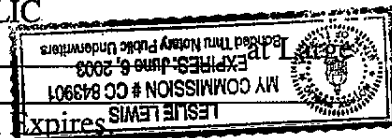
