The Corporation has no members.

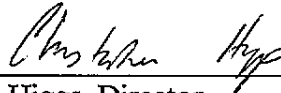

The dissolution of the Corporation was authorized by the unanimous consent of the three (3) members of the Board of Directors of the Corporation on November 1st 1999.

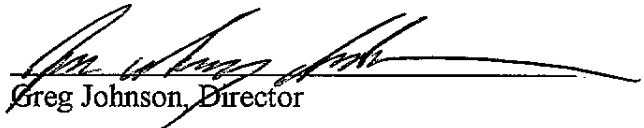
