ARTICLES OF INCORPORATION
OF

The undersigned incorporators of the House of Faith of Lord Jesus Christ of the Open Door Church Inc., in the Town of Malone, County of Jackson and the state of Florida, hereby associate themselves together as a Corporation not for profit as a benevolent association, under the following articles of Incorporation, to-wit:

ARTICLE I.

The name of the Corporation not for profit shall be "The House of Faith of Lord Jesus Christ of the Open Door Church Inc., and the place where said corporation shall be located is in the town of Malone, Country of Jackson, the state of Florida.

ARTICLE II.

The general nature and object of the Corporation shall be religious, its more specific object shall be to promote the religious, and spiritual life of the members of said church and of the members of all churches in said association or conference, according to their religious beliefs and convictions and as set forth in the Articles of Faith or spiritual guidance beliefs of said church; to promote for the organization of their associated churches, for the government and management of the church and all association churches, for the financial support of The House of Faith of Lord Jesus Christ of the Open Door Church Inc., and all member churches,

and all as may be here-in-after adopted by The House of Faith of Lord Jesus Christ of the Open Door Church Inc., to purchase, own, sell, mortgage and lease real estate and personal property for the purposes here-in-after set forth, and generally to have all power incident to Corporations of this Character.

ARTICLE III.

The membership of this Corporation shall consist of the ten subscribers to this Charter and such other persons, without regard to Race, Color, Religious or Denominations, Nation origin, Gender, or Handicap as defined by the Laws of the State of Florida, as shall here after be admitted to membership of said "The House of Faith of Lord Jesus Christ of the Open Door Church Inc., The membership in the corporation shall continue until such time as the respective members shall cease to be members of said Church, either by death, resignation or expulsion.

ARTICLE IV.

Directors should be elect, at a annual meeting of the members

ARTICLE VI.

The officers of this corporation shall consist of a Senior Bishop, who shall perform the duties of President, a Junior Bishop, who shall perform the duties of Vice President, Apostles, Prophets and Prophetess, Evangelists, Pastors, Teachers, a Secretary and a Treasurer, who may be the same person, a National Mother, State Mother, Chairman of the Missionaries, Chairman of the Young People's, Director of the Quire. Chairman of the Planning Committee, Chairman of the Elders, Chairman of the Pray Circle, Chairman of the counselors, Chairman of the School Committee, Chairman of the Community Relation, Chairman of Advertisement, and three Deacons. The said Corporation may have other Officers for the Government and conduct of its affairs as many be provided by its by-laws. not less than ten (10) members shall constitute a quorum to transact business at any regular or special meeting of the Corporation. The Meetings may be presided over by either the Senior Bishop or the Junior Bishop. The affairs of this Corporation shall be managed by Apostle Johnny Larry Jr., Senior Bishop, Junior Bishop, Larry Daniels, National Mother, Lillie B. Larry; State Mother, Delia M. Jonier; Secretary and Treasurer, Tameka R. Larry; Chairman of the Young People's, Shawna R. Larry; Three Deacons, Eric B. Dixon,

Dayvon R. Larry, Levi Brelove; as the Board of Directors until the first election of officers under this Charter.

ARTICLE VII

The By-Laws of this Corporation shall be made, altered, or rescinded by a majority votes of the members present at any regular or special meeting, due notice of which has been sent to all of the members, in accordance with the By laws, or has been given and announced from the Alter of the Church on three (3) successive Sundays, and in like manner this Charter may be amended, altered or rescinded.

ARTICLE VIII

The highest amount of indebtedness or liability to which this corporation may at any time subject itself shall be \$100,000.000 or two-thirds (2/3) of the value of the property owned by it, whichever shall be the smaller. No property belonging to the Corporation shall at any time be alienated or encumbered except by a majority vote of the members of the Corporation present and voting at a regular or special meeting duly called for that purposes. IN WITNESS WHEREOF, the said above named incorporators have hereunto affixed their hands and seals this the 23rd day of January A.D. 1998.
