ARTICLES OF INCORPORATION
FOR
TABERNACLE WORD CENTER, INC.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts following ARTICLES OF INCORPORATION.

ARTICLE I NAME

The name of the corp. shall be: TABERNACLE WORD CENTER, INC.

ARTICLE II INITIAL OFFICE

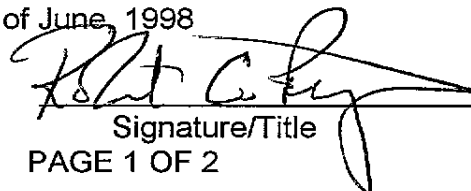

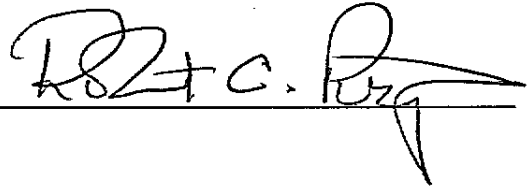

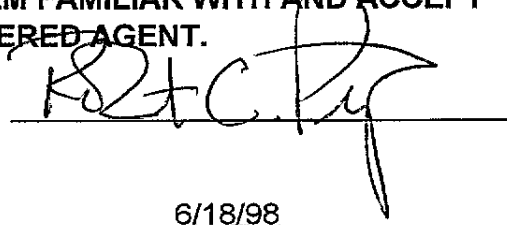
