The Name and address of this principal corporation is Booker T Wilson Ministries, Inc., 2119 NW 2nd Street, Pompano Beach, Florida 33069. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

TWO:

This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). The duration of this corporation shall be perpetual, no stock and shall have no members.
