# ARTICLES OF INCORPORATION

OF

# LITTLE HEARTS, INC. A Florida Not-For-Profit Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE ONE

### NAME

The name of the Corporation is LITTLE HEARTS, INC.

## ARTICLE TWO

# PRINCIPAL OFFICE

#### ARTICLE THREE

# **PURPOSE**

- A. The primary purpose of the Corporation is to assist children in crisis in whatever way possible.
- B. The other purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

- C. Notwithstanding any other provision of these Articles, this Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- D. Upon the dissolution of the Corporation, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding Section of any future federal tax codes or shall be distributed to the federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the circuit court of the county in which the principal office of the Corporation is then located, exclusively for such purposes.
