OF

The undersigned, for the purpose of forming a corporation not for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

Article I

Name

The name of the corporation is Lorenz-Smeenge Foundation, Inc., and the address of the principal office and mailing address of the corporation is at 1520 Tradeport Drive, Jacksonville, Florida 32218.

Article II

Duration

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

Article III

Corporate Purpose

This corporation is organized and shall be operated exclusively for religious, scientific or charitable purposes, not for pecuniary profit. No part of the net earnings of this corporation shall inure to the benefit of any private shareholder or individual. No substantial part of the activities of this corporation shall be to carry on propaganda or otherwise attempt to influence legislation, nor shall this corporation participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

Article IV

Members

This corporation shall have no members.

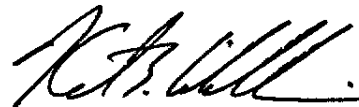
