**of**

(a non-profit corporation)

**ARTICLE I**

**Name**

The name of this corporation shall be DeBary Art League, Inc., a non-profit corporation.

**ARTICLE II**

**Address**

**ARTICLE III**

**Purpose**

The purpose of the corporation is to encourage and perpetuate appreciation of artistic endeavors including, but not limited to, production, preservation, conservation and viewing of the fine arts and the educational support of the arts in the community.

**ARTICLE IV**

**Directors**

The directors shall be elected according to provisions contained in the by-laws of the corporation as stated and amended from time to time.

**ARTICLE V**

**Powers of the Corporation**

## ARTICLE X

### Dissolution

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.
