The undersigned, for the purpose of forming a corperation not LORIDA for profit under the Florida Not For Profit Corporation Act, Accept the following Articles of Incorporation for the corporation:

ARTICLE ONE NAME

The name of the corporation is Jubilee - The Church, Inc.

ARTICLE TWO PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the corporation is 3518 Bankhead Road, Tallahassee, FL 32308.

ARTICLE THREE CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR PURPOSES

The corporation is a not for profit corporation. The corporation is organized for religious purposes, specifically a non-demoninational Christian church as stated below.

Jubilee- The Church is a Spirit-filled body of believers who believe the Bible is the inspired Word of God, who seek to reach out to Tallahassee and the surrounding communities so that others may know and experience Jesus Christ, and who desire to worship Jesus Christ Where the River of God flows freely.

The corporation is to operate exclusively for religious purposes as described above which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax exempt organizations under that Code.

This corporation shall not carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

The Pastor shall be the Chairman of the Board of Directors.
