The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is NORTHWEST FLORIDA VETERINARY TECHNICIAN ASSOCIATION, INC., a not for profit corporation.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is: 711 North Fairfield Drive, Pensacola, Florida 32506. The mailing address of this corporation is: Post Office Box 30302, Pensacola, Florida 32503.

ARTICLE III

PURPOSE(S)

The specific purposes for which the corporation is organized is to provide an association for individuals employed in technical support of veterinary medical care, and to provide continuing education opportunities for individuals who provide technical support to veterinarians.

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS

The manner in which the board of directors are elected or appointed is: the board of directors shall consist of the President, Vice-President, Secretary, Treasurer, the past president, and two (2) members of the association at large. At the March meeting of the association, the officers/directors of the association shall be elected for a term of one (1) year. Each officer/director must be a member in good standing and shall serve a term beginning June 1 of such year until their terms expires on May 31 of the following year.

ARTICLE V
