ARTICLES OF INCORPORATION (FOR) GLOBAL OUTREACH MINISTRIES, INC.

The undersigned, acting as **incorporator** of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following articles of incorporation of such corporation:

ARTICLE I

The name of the corporation shall be GLOBAL OUTREACH MINISTRIES, INC.

ARTICLE II

- D To serve as a resource clearinghouse to meet the needs of the body of Christ.
- E. Any other purpose as may be defined by the Board of Directors of Global Outreach Ministries, Inc. that would be in concert with the normal ministry functions in the Christian evangelical Community.
