ARTICLE I

This corporation shall be known as Generation Success, Inc.

ARTICLE II

The principal and mailing address of the corporation is 3238 East Highway 390, Panama City, Florida 32405.

ARTICLE III

The corporation's primary purpose shall be to promote and educate others in people-skills including, but not limited to, non-violence, drug awareness, team building, conflict resolution, time management, and communications.

ARTICLE IV

The officers of the Corporation shall consist of a president, a vice-president, a secretary, a treasurer, and such other officers, as the Board of Directors may from time to time deem advisable. 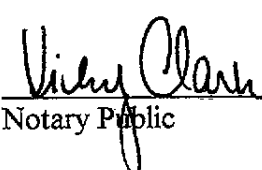

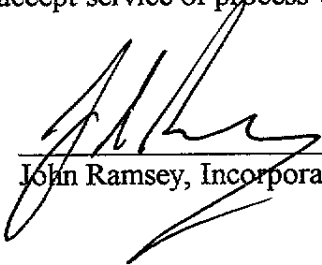

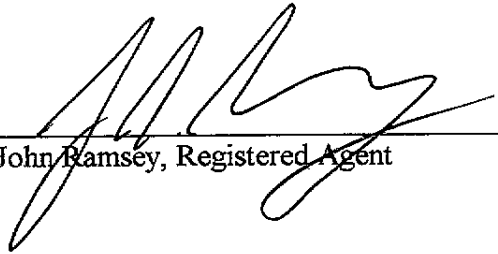
