Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.) Amendment to Article III

ARTICLE III

The purpose of this corporation shall be religious, charitable, scientific, literary, and educational within the meaning of section 501(c) (3) of the Internal Revenue code of the 1996 or the corresponding provision of any future United States Revenue law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Amendment to Article VII

ARTICLE VII

This corporation shall commence upon filing and shall have perpetual existence. This corporation is organized on a non-stock basis. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c) (3) and 170(c) (2) of the Internal Revenue code of 1986 or corresponding sections of any prior or future Internal Revenue code, or to the Federal, State or local government for exclusive public use.
