

AMENDMENT TO THE ARTICLES OF INCORPORATION 24 PM 2: 58

VILLAS I AT CARLTON LAKES ASSOCIATION, INC

The Articles of Incorporation of Villas I at Carlton Lakes Association, Inc. shall be amended as shown below:

Note: New language is underlined; language being deleted is shown in struck through type.

21. Article VII (C) shall be amended to read as follows:

(C) Vote Required. Except as otherwise required by Florida Law, a proposed amendment to these Articles of Incorporation shall be adopted if it is approved at any annual or special meeting called for the purpose by at least two-thirds (2/3rds) a majority of the voting interests of the Association who are present and voting, in person or by proxy, or if it is approved in writing by a majority of the voting interests without a meeting, as authorized in Section 3.11 of the Bylaws, provided that notice of any proposed amendment has been given to the members of the Association, and that the notice contains a statement of the proposed amendment.
