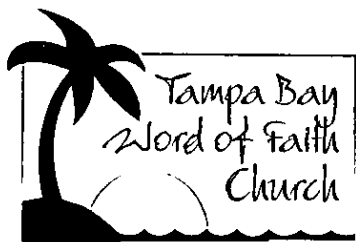

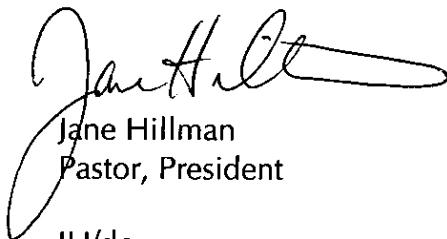
Dear Madam Secretary:
