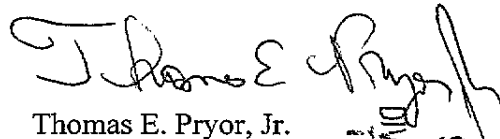

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as sole incorporator, does hereby desire to form a not for profit corporation pursuant to the Florida Not for Profit Corporation Act and does hereby adopt the following Articles of Incorporation:

**Article I-Name of Corporation**

The name of the corporation shall be **LEGACY DEVELOPMENT CORP.**

**Article II-Principal Place of Business and Mailing Address**

The principal place of business and mailing address of this corporation shall be **2625 Delcrest Drive, Orlando, Florida 32817.**

**Article III-Purposes**

The purposes for which the corporation is organized shall be educational, historical, and civic. It is intended that the corporation is organized for and may conduct and transact any and all lawful business authorized and not prohibited by the Florida Not for Profit Corporation Act, as the same may be, from time to time, amended.

The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by the Florida Not for Profit Corporation Act.

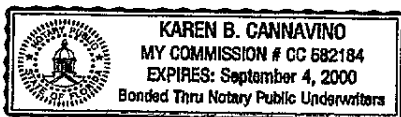
