NAME**

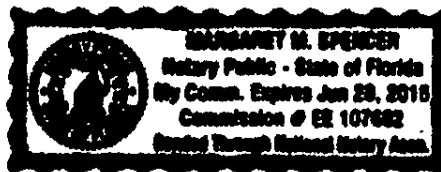
The name of the corporation is FLORIDA DESIGN FOUNDATION, INC.
