ARTICLES OF INCORPORATION

OF

A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do hereby agree the following:

ARTICLE I

The name of this corporation is:

COMMUNITY PLACE, INC.

The principal place of business and mailing address of this corporation shall be: 10361 Sabel Chase, Palm Beach Gardens, Florida, 33418.

ARTICLE II

The specific purpose(s) for the which the corporation is organized to provide housing for the homeless within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.
