ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Nkenge Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

523 West Forsyth Street - Jacksonville, Florida 32202

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are): to provide job opportunities, training, and educational enhancement for youth at risk. The objective is to exposed young people (especially youth at risk) to the arts through the music/recording industry. The youth will be selected from the Juvenile Justice division, school system, church organizations and other referrals.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is: There will be 13 board members. Three (3) chosen from the educational arena, 3 from the music industry, 2 from the Justice department, 3 from the business community, and 2 from the media (radio, television, paper, etc.)

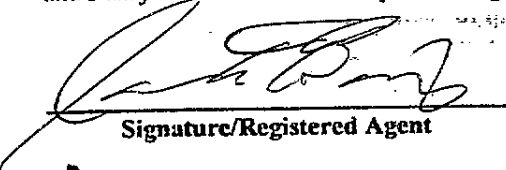
