ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

SUMMIT GREENS RESIDENTS' ASSOCIATION, INC. (a corporation not-for-profit) Document Number N98000004723

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation, originally filed on August 17, 1998:

1. The first sentence of Article VII is amended to state as follows:

The Board of Directors of the Corporation shall be comprised of not more than nine (9) directors.

2. In Article VII the paragraph directly after the listing of the names and addresses of the directors and directly before subparagraph (A) is deleted, and the following paragraph is substituted in it place:

The election of the initial Class A Members of the Board can take place at any time during a year by a Special Meeting called by the Developer. If the initial election takes place before March 31st of that same year, the Board will serve until January of the following year.

3. The amendments were adopted by the Members and the number of votes cast for the amendments was sufficient for approval.

In all other respects, the Articles of Incorporation are ratified and confirmed, subject only to the amendments set forth herein.
