The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be **CRIME STOPPERS OF LEVY COUNTY, FLORIDA, INC.**

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 130 S. Main Street, Williston, Levy County, Florida 32696.

ARTICLE III

PURPOSE

The specific purpose for which the corporation is organized is to assist law enforcement agencies with information on unsolved crimes, wanted persons, and other criminal activity, lessen neighborhood tensions, promote community involvement in all aspects of law enforcement, promote a community offensive against violent and property crimes, motivate the public to cooperate with law enforcement agencies and to reward such cooperation.

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS

The directors shall be appointed by the general membership at the annual meeting.
