Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted:

ARTICLE IV

Said corporation is organized exclusively for charitable, educational and scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under

I, the undersigned, do hereby make, subscribe, acknowledge and file these amended Articles of Incorporation for the purpose of clarifying the establishing a corporation not for profit, under the provisions of Chapter 617, Laws of Florida and section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE I

The name of this corporation will be SpecialKids Resource Center, Inc.

ARTICLE II

The general purpose for which this corporation is: SpecialKids Resource Center Inc. is a non-profit corporation providing a clinical program for individuals from Birth to 21 years of age which includes assessment, treatment, consultation, advocacy, evaluation and research for Behavioral Sensory Spectrum Disorders (BSSD's) and provides families a comprehensive, interdisciplinary, and state of the art assessment and treatment services. It assists identified individuals with BSSD's to become more fully functional, able to live as independently as possible, become wage earners and constructive citizens in their communities. Behavioral and Sensory Spectrum Disorders are any neurologically, emotionally or physically based behavioral issues which keep an individual from developing normally with full coordination of gross and fine motor skills, with complete age appropriate speech, language

Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VI

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.
