The undersigned subscriber, acting as incorporator of a corporation, pursuant to Chapter 617, of the Florida Statutes, adopts the following Articles of Incorporation for the formation of a non-profit corporation:

ARTICLE ONE

The name of the Corporation shall be Set Free In Christ Ministries, Inc..

ARTICLE TWO

The initial principal address of the corporation is 5824 Orange Street, Marianna, Florida, and the initial mailing address of the corporation is 4197 Myles Street, Marianna, Florida 32448.

ARTICLE THREE

The general nature of the business to be conducted by the corporation shall be the delivery of Christian ministries, and the operation of any other lawful purposes authorized under Chapter 617 of the Florida Statutes. The corporation shall remain a non-profit corporation and intends to qualify as an exempt corporation under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE FOUR

The period of duration of the corporation is perpetual unless dissolved according to law.

ARTICLE FIVE


