## ADOPTION OF AMENDMENTS

This is to certify that the Boad of Directors of the American Association for the Advancement of White People met on January 13, 1999 to adopt and did adopt the following amendments to their Articles of Incorporation to be filed with the Secretary of State of the state of Florida.

Amend Article III PURPOSE(S) to: Said corporation/organization is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code ( or corresponding section of any future Federal tax code.)

Insert and renumber Article V EARNINGS to: No part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda , or otherwise attempting to influence legislation , and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political compaigns on behalf of or in opposition to any candidate for public office.

Renumber Article V to read Article VI INITIAL REGISTERED AGENT AND STREET ADDRESS

Insert Article VII DISSOLUTION to read Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.
