## ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF CHARLES L. ROESEL MINISTRY EVANGELISM, INC.

The undersigned, President of CHARLES L. ROESEL MINISTRY EVANGELISM, INC., a Florida nonprofit corporation (the "Corporation"), desiring to amend the Amended and Restated Articles of Incorporation of the Corporation under the laws of the State of Florida, states as follows:

- 1. The name of the Corporation is CHARLES L. ROESEL MINISTRY EVANGELISM, INC., Document Number N98000004819.
- 2. The Articles of Incorporation of the Corporation are amended by deleting Article X. Section B and replacing it with the following:
  - Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation to the Church as a restricted gift for the exclusive use by the Church for the ministry of Christian Care Center, Inc. In the event Christian Care Center, Inc. is no longer controlled by, an integrated auxiliary of, or a supporting organization of, the Church at the time of the dissolution of the Corporation, or if the Church will not receive or recognize restricted gifts, the assets of the Corporation shall be distributed in dissolution directly to Christian Care Center, Inc., if Christian Care Center, Inc. is of active status and operating, otherwise to the Church without restriction. Any assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes consistent with the purposes of the Church and which qualify as an exempt organization under section 501(e)(3)of the Code."
  - 3. The Corporation does not have members.
