ARTICLES OF INCORPORATION FOR OSCEOLA GIRLS FASTPITCH, INC.

The undersigned, acting as sole incorporator under the Florida Not For Profit Corporation Act, adopts the following articles of incorporation for Osceola Girls Fastpitch, Inc.

- 1.) The name of the corporation is OSCEOLA GIRLS FASTPITCH, INC.
- 2.) The corporation's duration shall be perpetual.
- 3.) The purpose of the corporation is to develop amateur athletes for national competition in girls fastpitch softball through conducting local and participating in national competitions. The corporation is not for profit and no part of the corporation's net earnings may inure to the benefit of any private shareholder or individual. No substantial part of the corporation's activities may consist of carrying on propaganda, or otherwise attempting, to influence legislation. The corporation shall not participate in or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office.
- 4.) The qualifications for members and the manner of their admission shall be regulated by the bylaws .

Notwithstanding any other provision of these Articles, neither this corporation nor any of its directors, officers, employees, or representatives shall carry on any activities or take any actions on behalf of the corporation which are not permitted to be carried on by an organization exempt from federal income tax under sections 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law, or by an organization, contributions to which are deductible under sections 170 (c) (2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law.

In the event of dissolution of this corporation the Board of Directors shall dispose of the assets of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under sections 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principle office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes. No private individual shall share in the distribution of any corporate assets upon the dissolution of the corporation.

This corporation shall not apply accumulation of income in any manner which may subject it to denial of exemption as provided under sections 504 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law.
