ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be:

THE HISPANIC MINISTERIAL ASSOCIATION OF MARION COUNTY, INC.

The principal place of business of this corporation shall

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are:

1. To coordinate with the different Community Service Agencies in order to help minorities.
2. To offer legal aid to people with low income.
3. To offer christian clinical counseling to people with low income.
4. To create a clothes bank and a food bank.
5. Provide information concerning state and local government laws.
6. Promote cooperation with law enforcement and use of proper channels.

ARTICLE IV

The qualifications for members and directors, and the manner of election of their admission are to be provided for by the bylaws of the corporation.
